The property will be offered for sale by private treaty as a whole. Offers are to be made in writing to Ian Ritchie Land Agents Ltd.

General Description

The land has a mains water supply and lies in a single field enclosure extending to 3.73 acres (1.51 hectares) or thereabouts. It is sown down to grass and has been used to graze cattle until recent times. The land is located in unspoilt open countryside and whilst currently being used for agricultural purposes it may also be suitable for re-wilding, equestrian use or for somebody wanting their own property just to get away from it all. Access to the field is taken direct from the public highway. The field also has within it the remains of an old limestone kiln.

The land lies outside of the Nitrate Vulnerable Zone (NVZ) and according to Ordnance Survey Maps is not affected by any footpath or bridleway. The land lies at approximately 240m above sea level.

The opportunity to purchase a property such as this is rare and therefore prospective purchasers are advised to contact the selling agents to register their interest as quickly as possible.



General Remarks

Tenure

We understand that the title of the property is freehold. The land will be sold with the benefit of vacant possession.

Exchange of Contracts, Vacant Possession and Completion

The purchaser(s) will be required to pay a 10% deposit of the purchase price on exchange of contracts. The deposit will be non-refundable in the event of the purchaser(s) being unable to complete a sale for any reason not attributable to the Vendors or their agent. Vacant possession will be given on completion.

Matters of Title
