The property will be offered for sale by private treaty as a whole. Offers are to be made in writing to Ian Ritchie Land Agents Ltd.

General Description

The land is located in unspoilt open countryside and whilst currently being used for agricultural purposes it may also be suitable for re-wilding, equestrian use or for somebody wanting their own property just to get away from it all. Access to the field is taken direct from the public highway via its own access track. Located within the field is a steel framed general purpose agricultural building (9.15m x 9.15m) with two shipping containers located within it. The vendor has confirmed that the property has a borehole located adjacent to the building. To draw water from the borehole the vendor has used their own portable generator to power the pump. Purchasers will need to purchase their own generator if they wish to use the borehole water supply. Also included in the sale is a small caravan which we understand has planning permission granted for it to be located in its current position.

The land lies outside the Nitrate Vulnerable Zone (NVZ) and according to Ordnance Survey Maps is not affected by any footpath or bridleway.

The opportunity to purchase a property such as this is rare and therefore prospective purchasers are advised to contact the selling agents to register their interest as quickly as possible.



General Remarks

Tenure

We understand that the title of the property is freehold. The land will be sold with the benefit of vacant possession.

Exchange of Contracts, Vacant Possession and Completion

The purchaser(s) will be required to pay a 10% deposit of the purchase price on exchange of contracts. The deposit will be non-refundable in the event of the purchaser(s) being unable to complete a sale for any reason not attributable to the Vendors or their agent. Vacant possession will be given on completion.
